


Since moving to Washington State, Sandra has become a certified marine naturalist



Over the past 30 years, her articles on cycling, cruising, and women's issues have appeared in numerous outdoor magazines. In the 1980s, she led the first women's bicycling team across Tierra del Fuego at the tip of South America. **Réanne Hemingway-Douglass**, along with her husband Don Douglass were founders of Fine Edge Productions in 1986. For four decades they have been producing outdoor and nautical guidebooks and maps. Their popular *Exploring* series of six nautical guides cover from the border with Mexico to Prince William Sound in Alaska, including *Exploring the Pacific Coast, San Diego to Seattle*.

With their new imprint, Cave Art Press they have broadened their scope from cruising and mountain biking guides to high-quality titles of general interest. The Cave Art Press name and logo are derived from the Douglasses' enduring interest in the 7,000-year-old cave paintings of the Baja Peninsula, which they first began exploring in the late 1970s.



Réanne holds a B.A. in French from Pomona College and a teaching degree from Claremont Graduate University. Together the Douglasses have logged over 150,000 nautical miles, from 60°N to 63°S latitude.

Cape Horn - One Man's Dream, One Woman's Nightmare

His Dream — a lifelong goal to round Cape Horn and circumnavigate the Southern Hemisphere in their sailboat.

Her Nightmare — coping with her husband, a driven captain, and the frightening seas of the Great Southern Ocean.

Eight hundred miles WNW of Cape Horn they encountered the Ultimate Wave which pitch-poled their sailboat and turned it into a leaking lifeboat. Pulling together, they struggled over 42 days to reach the coast of southern Chile while family and friends all but gave up hope. Cape Horn is the gripping account of one woman's courage, a couple's turbulent relationship, survival, and endurance in the seas off Patagonia.

AAUW Washington Update

SUCCESSFUL LOBBY DAY by Bunny Heiner

Despite leaving at 5 a.m. on Monday, 26 January, a very

foggy morning, Andrea Doll and I were surprised to encounter such heavy traffic so early in the day. With a few



"adventures" on the way (a couple of wrong turns), we arrived in Olympia in time for the start of the program at 8:30 a.m. This very well-organized event is put on annually by the Olympia branch of AAUW. We met up with copresident Rosette Dawson at the event. She had driven down to Olympia on

Sunday in order to be on hand to attend Sunday's statewide AAUW meeting.

The morning was devoted to excellent speakers. (Pictured right: Lobby Day Panel: moderator at mic, Cheryl Sesnon (Jubilee Women's Center Executive Director); Mia Gregerson (Representative, 33rd Leg. Dist., and Mayor of SeaTac, WA); Kim Mead (Washington Education Assn. President); Liz Berry (Washington Women's Political Caucus, President) First up was a panel of four women with a moderator, who



discussed a wide variety of topics, from homeless shelters to lobbying. Next on the agenda was Randy Dorn, state Superintendent of Public Education, who spoke for an hour about the McCleary decision and the background of the educational levy system in our state. A law passed in 1977 limited a 10% levy cap; several school districts, including Mercer Island and Lake Washington, were "grandfathered" in at a 36% rate. "Levy" creep has brought the present-day average levy rate to 26%. Dorn explained that the original purpose of levies was M&O (maintenance and operations). The State Supreme Court's McCleary decision found that levies, which have been funding teachers' salaries, regular transportation (as opposed to transportation for band and sports trips and other field trips) was unconstitutional, as it is "the paramount duty" of the state to provide "ample" and "uniform" education for *all* children. With the wide range of levy amounts collected in various school districts, these constitutional requirements have not been met for years.

McCleary mandates the following funding:

- Full funding for student transportation;
- Full funding of materials, supplies, and operating costs (MSOC);
- Funding for all-day kindergarten (which used to be set at funding for 450 hours); and
- Lowering class size in grades K-3 to 17:1

Full funding under the McCleary decision will cost \$7.1 billion by 2018; the state currently is funding at \$1 billion. Because of the huge dollar amounts of money needed to fund McCleary, Dorn said he did not think the state would be able to fund the mandates to implement Initiative 1351, which passed by a very narrow margin in the November 2014 election.

Dorn said that the state high school graduation rate is 81%, with 78% of students graduating within the traditional four years. He commented that although these rates are good, that still leaves some 20% of all students leaving school without a high school diploma. (Randy Dorn pictured in photo to the left)

The final speaker was Pam Crone, AAUW-Washington lobbyist and legal voice, who discussed what is and would be happening in the legislature this session, a long session of 105 days. (The

biennial budget is set during the long sessions.) She said that she thinks with all the major issues to be resolved this year, the legislature probably will need to go into special session, especially since additional funding will be needed for several Supreme Court mandates (including McCleary and mental health), which means higher taxes, never a popular subject.

This year the legislature is faced with the "three M's": McCleary, marijuana (especially regulation of the medical marijuana market), and mental health. Crone said that behavior health is now being integrated into mental health, both under primary health care.

The two primary AAUW issues are House Bill 1356/Senate Bill 5306, mandating 40 hours of paid sick leave annually, and (yet again) the pay equity issue, House Bill 1355 (Crone did not know the Senate bill number). She said the pay equity issue may be resolved through the initiative process; the goal is a \$12.00 hourly wage statewide, to be implemented over a four year period. This year "pay equity day" is 14 April. White women will reach pay equity in March, Black women in June, and Latina women not until October. The earnings ratio for our Congressional District is 78%, a ranking of seven in the ten state Congressional districts.

Other issues Crone discussed included violence against women (some funding to come from a \$15.00 fee applied to marriage licenses) and reproductive health. If medical insurance covers medications, then reproductive health medications must also be covered, as must all approved medications, and if maternity coverage is covered, then abortion services must also be covered. Other issues in the reproductive health category include parental notification and religious exemptions.

Following an excellent box lunch from noon to 1 p.m., the meeting was concluded and the attendees then went to see their legislative members. We three went to the offices of District 10 Senator Kevin Ranker and Representatives Kris Lytton and Jeff Morris. Unfortunately, all three were in meetings (meeting seemed to be going on everywhere at the capitol), so we left the official AAUW information sheet on pay equity and paid sick leave with each member's legislative assistant.

Once the fog lifted, about 8 a.m., we enjoyed a beautiful, sunny day. Our drive home was delayed by more than an hour by an accident south of Tacoma, which brought traffic to a virtual stand-still. All-in-all, it was a very good and very productive day. I urge all branch members to consider attending the 2016 Lobby Day.
